#### IF YOU WITHDRAW FROM A WEEKEND TRIP PRIOR TO THE FINAL PAYMENT DATE

- You will forfeit your initial deposit
- Your post-dated cheque will be returned to you or destroyed at your request
- If you paid in full and withdraw from the trip prior to the trip's published final payment date, you will receive a refund for the amount paid less your initial deposit

#### IF YOU WITHDRAW FROM A WEEKEND TRIP AFTER THE FINAL PAYMENT DATE

- You will forfeit the entire trip fee
- If you can be replaced by a member on the waiting list, you will be refunded the amount paid less the initial deposit and any
  additional costs incurred by North Toronto Ski Club
- If you fail to complete your final payment by the final payment date, the Charter Director shall treat you as having withdrawn
  from the trip

## WAIVER

In consideration of the acceptance of this trip application, I hereby waive all claims and rights of action, present or future, whether for personal injury, financial loss or otherwise, against the North Toronto Ski Club (NTSC), its directors, chairpersons, and members, with respect to this trip.
