CANCELLATION POLICY

Hotel and flight space may be cancelled by NTSC without penalty up to 61 days prior to departure. 61-45 days prior to departure = loss of deposit 44-31 days prior to departure = 50% loss 61-45 days prior to departure = 100% loss

All names MUST be supplied to us by 31 days before departure. Name changes allowed up to 31 days before departure.

INSURANCE PROTECTION (Optional)

We advise both medical and cancellation/interruption insurance for a ski trip outside Ontario. Cancellation insurance may only be purchased at time of trip deposit. Costs are as follows:

0 to 59 years of age: Medical = \$16.00; All-inclusive Cancellation/Interruption, Medical & Baggage = \$104.00. 60 to 64 years of age: Medical = \$21.00; All-inclusive Cancellation/Interruption, Medical & Baggage = \$113.00. 65 to 69 years of age: Medical = \$30.00; All-inclusive Cancellation/Interruption, Medical & Baggage = \$121.00. 70 to 74 years of age: Medical = \$76.00; All-inclusive Cancellation/Interruption, Medical & Baggage = \$132.00 75+.
